1st Meeting

held at the Offices of the Bank of Cyprus, Nicosia
on Sunday the 17th day of April 1927 at 10.30 a.m.

1. Mr. J. Leonovides was asked to take the Chair presiding the election of the Chairman of the Council.
2. Election of Chairman:- A ballot having been taken, Mr. H. H. Jones was elected by 12 votes to 1, Chairman of the Council.
3. Election of Vice Chairman:- A ballot having been taken, Mr. J. Leonovides was elected by 12 votes to 1, Vice Chairman of the Council.
4. Election of Treasurer:- Mr. Eleutherios Christofides was unanimously elected Treasurer of the Council.
5. Appointment of Secretary:- The Chairman proposed Mr. H. W. Carter as a candidate for the post of Secretary.
 He said that Mr. Carter was the head master of the English School, Nicosia, as taught, particularly, commercial subjects. Mr. Carter had a good working knowledge of English, French, Italian & Greek.

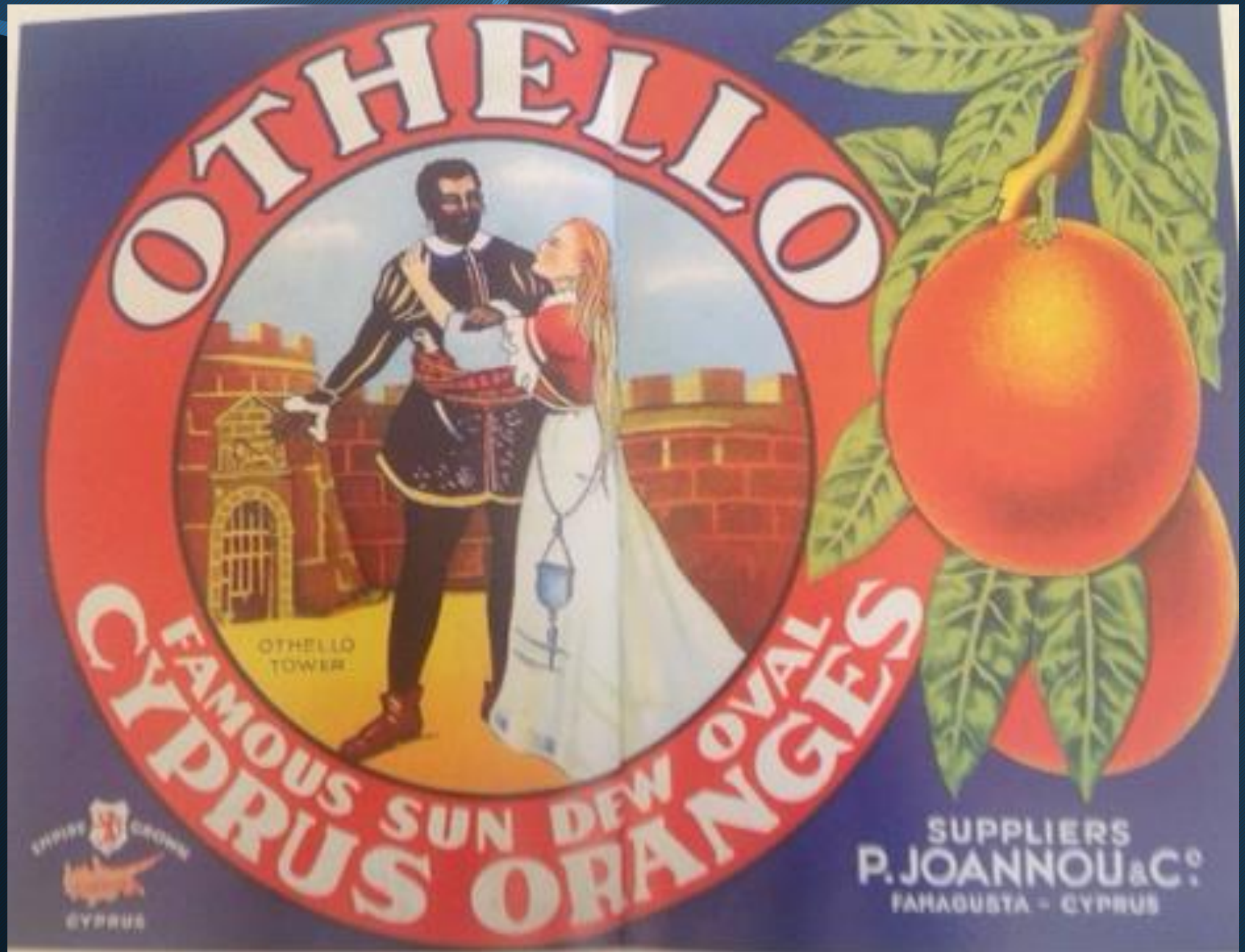
ΑΜΜΟΧΩΣΤΟΣ, 23 (Τοῦ ἀνταποκριτοῦ μας). — Ὁ Ὑπουργὸς Ἀναγκύλειας καὶ Προόδου Ἀμμοχώστου ἐν τῇ ἐπιθυμίᾳ του ὅπως συνενόησιν τὰς προοπτικὰς διὰ τὴν ἀνάπτυξιν τοῦ Τουρισμοῦ, ἀρξάμενος τὴν 21ην τρέχοντος εὐσκεπὴν μετὰ τοῦ ἀρχιεπισκόπου τοῦ Συμβουλίου καὶ τῶν διευθυντῶν τῶν ξενοδοχείων «Κωνσταντῖνα», «Φλωρίδα», «Κίγκ Τζόρτζ», «Φορμάνκοστα Πάλας» καὶ «Ξαφὸς». Κατὰ τὴν σύσκεψιν ταύτην ἀντηλλόγησαν ἐπιχειρήσεις ἀποφασιστικαί μετὰ τὴν ἀνέγκασιν τοῦ ἐπιπέδου τῶν ξενοδοχείων, ἐν ὅροις τῆς ἀναμενόμενης ζωηρᾶς τουριστικῆς κινήσεως.

Διεπιστώθη ἡ ἐκότερωθεν διαθεσιμία πρὸς δημοσιεύσιν ἄλλων τῶν προοπτικῶν ὥστε ἡ Ἀμμοχώστου ν' ἀποβῇ ἐπὶκαρπὸν τῆς τουριστικῆς δραστηριότητος. Ἐνεπίσθη βεβαίως ὁ τόπος διωθῆται φυσικῶς καλλώνως, καὶ ἄλλα πλεονεκτήματα τὰ ὁποῖα δέον ν' ἀξιοποιηθῶν καταλλήλως.

Πρὸς ἐνίσχυσιν τῶν τουριστικῶν δυνατοτήτων τῆς πόλεως, δέον νὰ

ἀρξασώμεθ' ἀρτιπύρην ξενοδογησιακὴν δραστηριότητα ὅσῃν πρὸς ἀποκαταστάσιν περιβλεπώμεθ'. ἔχει μόνον κατὰ τὴν ὁρμὴν παλαιῶν, ἀλλὰ καὶ ἄλλων εἰς τὴν Ἐπεξεργασίαν ἡ ἰδιοκτήτρια μερίμνα πρὸς καθύλην εἰς τοὺς ἐπισκέπτας ἄλλων τῶν συγκινησίων ἀνέστην, περιλαμβανομένης ἐκτεκτῆς ἐπιμέλειας ταφῆς, ἐκτεκτῆς καὶ ἐκτεκτῆς ἀποκαταστάσεως καὶ τῆς Εἰσαγωγῆς ἐκτεκτῆς καὶ ἐκτεκτῆς ἀποκαταστάσεως τῶν ξενοδοχείων διὰ καταλλήλως προσαρμογῆς ὑπογράφοντες τὰ καθήκοντα τῆς Κυβερνήσεως νὰ εἰσῇ ἀρμυρὸς εἰς τὴν ἐνδυνάμωσιν. Ἐπιχειρήσεις διὰ ἀποκαταστάσιν ἀσυνείων καὶ ἄλλων ἀποκαταστάσεων.

Ἐν τέλει, ἡ ἀντικειμένη ἀποφώνως καταλλήλως εἰς τὸ συμπέρασμα, ὅτι μεγάλῃ ὀφείλει δόσιν νὰ προσέσῃ διὰ τὸν Τουρισμὸν ἀπὸ παραμύθας ἐπιμέλειας καὶ ἀποφάσεις ὅπως καὶ διευθύνται τῶν ξενοδοχείων καὶ ἐν δ. 2. τοῦ Ὑπουργοῦ συνενδύονται τακτικῶς πρὸς ἀνταλλογὴν ἀποφάσεων.
